Group Transparency Statement

INTRODUCTION

This statement is made by Springfield Properties Plc ("**Springfield**") on its own behalf and on behalf of the subsidiary companies listed on the final page. This statement is made in accordance with section 54 of the Modern Slavery Act 2015 (the "**MSA**") and covers the financial year ending 31 May 2019.

Springfield supports the objectives of the MSA and we are committed to trading ethically and to the highest standard. We recognise our responsibility under the MSA and aim to ensure that no modern slavery, human trafficking or forced labour is present in any part of our business or supply chain.

This statement be reviewed and updated annually in accordance with MSA.

OUR BUSINESS

Springfield is a public limited company (SC031286). It is a Scottish house builder with offices in Elgin, Larbert and Glasgow. Our business involves buying land for developing, gaining planning consents and building private and affordable homes in Scotland. All of our active and past sites are in Scotland.

The annual turnover of Springfield for the financial year ended 31 May 2018 was £140.7m.

We directly employ c.620 employees with sub-contractors and suppliers visiting our sites on a daily basis and carrying out a range of work. Our operations mean that we have no direct contact with countries that are generally regarded as most likely to have a risk of modern slavery and/or human trafficking. Further information about our business and supply chains can be found in our 2018 Annual Report which can be found on the Investor Relations section of our website.

We act ethically and with integrity. Our employment policy requires all potential employees to provide evidence of their entitlement to work in the UK. We are committed to fair employment practices and (as a minimum) to following all applicable employment laws.

SUPPLY CHAIN

Our supply chains include building contractors, sub-contractors, product suppliers and professional consultancies e.g. engineers and land surveyors. Other suppliers to our business are professional services firms such as lawyers, accountants and other consultants.

The majority of our onsite construction is carried out through our sub-contractors and our building materials sourced through suppliers.

Respecting human rights and environmental issues in the supply chain is ultimately our supplier's responsibility. That said, to date we have not been made aware of any human trafficking / slavery activities within our supply chains but if any were brought to our attention then we would act immediately in accordance with our legal and moral obligations.

ANNUAL REVIEW

During the current financial year, we have reviewed our practices, policies and procedures. We believe the main areas of risk of modern slavery to Springfield's business would be our subcontractors and suppliers. We take this risk seriously and consider this when instructing new sub-contractors and suppliers. Our aim is to work with sub-contractors and suppliers who are also committed to tackling and preventing modern slavery.

We will continue to review the risk of modern slavery within our business and supply chain and update our applicable policies regularly.
