Company policies and procedures are communicated to all employees during their induction.

Updates and amendments to policies and procedures are communicated to all employees by whichever method is deemed appropriate.

Van Elle have taken steps to meet our statutory obligations ensuring that acts of slavery or human trafficking are not evident in our business or our supply chain but acknowledge that we cannot control the actions of suppliers or individuals outside of our operation.

We maintain and monitor a supplier approval system that includes a specific request for objective evidence of compliance with Section 54, Clause 5 of the Modern Slavery Act and expect our suppliers to do likewise.

We confirm the eligibility of each of our employees to work in the UK and confirm with each supplier that they also have a process of confirmation when supplying labour.

We have implemented training for all employees within our organisation, appropriate to their role, to ensure they are able to identify the signs of slavery and human trafficking and the associated risks.

We have a range of established policies that include Equal Opportunities & Diversity, Corporate Social Responsibility, Whistle Blowing, Worksafe and Anti Bribery that are reviewed at least annually.

Additional Steps

The additional steps we take to achieve and strengthen our compliance with Section 54, Clause 5 of the Modern Slavery Act include

continuing to only purchase through approved, reputable companies

reacting to information and recommendations from government and industry bodies, to deliver an appropriate and effective response to modern slavery.

ceasing to trade with any supplier that has been identified to us as being involved or connected to slavery or human trafficking.
