## To Christen Dobson & Michael Clements – Business & Human Rights Resource Centre

At the outset, we thank you for reaching out and providing us with an opportunity to present JSW Utkal Steel's perspective.

The background to this project and our response is as follows –

- The Government of Odisha had signed a Memorandum of Understanding with POSCO of South Korea in June,2005 for establishment of a 12 MTPA Integrated Steel Plant in Jagatsinghpur district of Odisha with a Captive Port. The Project required 4004 acres of land including 437 acres of private land spreading over eight revenue villages. The Central Government accorded forest clearance in May, 2011. Subsequently the betel vines were removed by the District Administration and IDCO (Odisha Industrial Infrastructure Development Corporation) which is the agency of the State Government to make the land encroachment-free. The land which was made encroachment-free was handed over to IDCO.
- In 2017, JSW proposed to set up a steel plant over lesser land (3160 acres) at the same location with the same capacity. In this regard the land requirement has been assessed by MECON, the Central Government agency and approved by IPICOL (Industrial Promotion and Investment Corporation of Odisha). The transfer of forest clearance has been approved by the MoEF&CC (Ministry of Environment, Forests & Climate Change) and subsequently the State Government has also passed the necessary order.
  - (Please note that MoEF&CC is the nodal agency in the administrative structure of the Central Government for the planning, promotion, coordination and overseeing the implementation of India's environment and forest policies and programs)
- Out of the total land requirement of 3160acres only 2.26 Ac is private land. The land owners have already given their consent for handing over the private land with permission from district administration. After the permission to utilize the forest land for establishment of the Steel Plant, from the MoEF&CC, District Administration started the process of alienation of Govt land.
- A special Rehabilitation and Resettlement (R&R) package has been framed, over and above the provisions in Odisha R & R Policy. Prior to finalization of the R & R package, public hearings / consultation were carried out in each of the Gram Panchayat¹ offices, which was attended by the local inhabitants and the elected representatives such as member of parliament(MP),member of legislative

assembly (MLA), Sarpanch<sup>2</sup>, Zilla Parisad Member, ward members etc. The package was well appreciated by the locals<sup>3</sup>.

- The name of the people mentioned in the mail, and referred as HRDs are from the village Dhinkia. It may be noted that, only 45 acres of the Government land from village Dhinkia are included in the project as against the total land requirement of 3160acres. There is not a single displacement from the Dhinkia village. Contrary to the claim of the Dhinkia, the rest of the villages are happy with the R&R and the project activity that would provide soci-economic improvement of the area.
- During the interaction meetings, some of the villagers requested to consider for preferential engagement/employment as per their eligibility and qualification. They also suggested for arrangement of appropriate trainings to upgrade their skill to make them employable. JSW has already started providing employment to the locals in the operating business from the group, although the project activity is yet to start. The project has the potential to generate employment opportunities of around 12000 direct and 45000 indirect employments during the operation phase. As mandated by environment clearance, a green belt of over 33% of the total area will be created.
- It won't be prudent on the part of the company to comment on the police actions which is beyond JSW's control, however it may please be noted that "in any country, whether developed, developing or under developed, nobody has the right to take the law into their own hand, if such a situation arises the police maintain the law and order of the society."
- It may please be noted when an Environment Clearance (EC) is granted it stipulates "Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010." Accordingly, the project EC was challenged and Hon'ble NGT has directed the authority to apprise the EC conditions in light of the seven observations made in the judgement within three months and till such time the EC would remain suspended. Respecting the judicial pronouncements, the MoEF&CC has already stated the process of re-appraisal.

## 41 youth get appointment letters

The ground-breaking ceremony of the pellet plant for JSW Utkal Steel (JUSL) greenfield project coming up at Nuagaon, Dhinkia and Gadakujung panchayats under the Ersama blocks of Jagatsinghpur District was held on Friday.

PRI members sarpanches of the area were present and expressed their happiness.

The test piling work would commence soon.

Forty one youth from the plant site were offered employment letters for jobs at BPSL (a subsidiary of JSW).

The President and whole time Director of JSW sub-



sidiary BPSL, Anil Singh has been recently appointed as the new project head of the upcoming Greenfield Steel

Singh underlined the importance of the day and assured expeditious completion of the project with the cooperation of local people.

An alternative livelihoods

program for the economicallyvulnerable population at the site has been implemented. Between Dec 2022 to March 2023, the program provided alternative livelihood opportunities to 456 individuals across the GPs in form of poultry, goatery, dairy and mushroom cultivation. Overall, the program is expected to benefit a total of 2041 individuals across the landlosing villages by FY 2024-25.

A total of 151 youth have been trained. By the end of FY 2024-25 a total of 440 youth would be skilled.

It is pertinent to note that after POSCO withdrew its proposed mega steel mill project in the same area, the JSW has started work.

# People in neighbourhood of JUSL's steel project at Paradip unhappy over NGT order

EXPRESSING anguish over the latest decision of the National Green Tribunal (NGT) in which Ministry Union and Environment, Forest Climate Change (MoEF&CC) has been asked to make appraisal afresh of the EAC with regard to the greenfield steel project of JSW Utkal Steel Ltd (JUSL), the people in the neighbourhood of the project site here have appealed to state government to take steps to thwart the attempts of the saboteurs out to upset Odisha's industrial growth roadmap. However, as the fresh appraisal is to be completed in three months by MoEF&CC, the EC will remain suspended till that period only, as per the NGT order.

Notably, the Kolkata bench of the NGT in its recent order has asked the MoEF&CC to take into consideration some other issues before EAC mak-



ing a fresh appraisal for issuing the EC. "We allow these appeals and remit the matter to the MoEF&CC for fresh appraisal and decision by MoEF&CC in the light of above observations which may take place within three months. Till such decision, ECs will remain suspended," the order passed by the NGT Bench headed by Adarsh Kumar Goel.

Apart from significant issue of public hearing, important issue of location of the project close to polluted area, jetty being unnecessarily close to an established port, huge water being taken from the river which may affect drinking

water needs and flow of the river are important issues which need express consideration, the Order said while asking MoEF&CC to go for a fresh decision following fresh appraisal by the EAC.

Some of the villagers in the neighbourhood of this proposed mega steel project told PBD that causing such roadblocks suits only the environment hawks, but dampens the spirit of the local youth and others who were eagerly waiting for this industry to come up without further delay.

People at the JUSL site have already lost sizable betel vines. In such a scenario, delaying project work is going to worsen the sufferings of the locals, said an industry expert. State has lost out on mega investments of steel giant POSCO and aluminium behemoth Vedanta in the past and such development will

not augur well for the investment climate of Odisha, he said.

Lipuna Khuntia Nuagaon, Ananta Behera of Dhinkia and Chinmay Rout of Gada Kujanga expressed shock at this development and said, "We some ITI pass-outs of the nearby villages are immensely excited to get jobs in this project which offers immense opportunities to local youths. Whe atmosphere was buoyant in the neighborhood, seeing the rapid development in the project work here, such destructive agendas of saboteurs should not be allowed to succeed."

Stating that small hurdles are part of mega projects, a senior functionary of JUSL informed PBD, "While as many as 41 youth from the site received employment letters on March 17, 2023, thus far over 200 such youngmen have got direct employment in JUSL." In addition, JUSL has also opened up indirect livelihood opportunities to local women SHGs and others, the company official further added.

# JSW declares attractive special R&R package

Reaching out to people of its proposed project site area, the JSW, declared its compensation package claiming that it is was way above the policy provisions outlined in the Rehabilitation and Resettlement Policy of the state government.

Project affected people living in villages of Nuagaon, Gada Kujang & Dhinkia gram panchayat, for its Integrated Steel Plant at Paradip will get Rs 17,500 per decimal compensation for betel vines plus Rs 50,000 as bonus and as far as employment is concerned it invited applications from youth.

The company said the package was formulated after extensive discussion with all the stake holders.

"JSW is stepping up CSR activities in the project site for the all-round development of the region," said Mr Ranjan Nayak, COO, JSW Steel operations, Odisha. "We are taking up livelihood of the people from the project villages as a priority area and are coming up with a roadmap to address it," he added.

The VLC engagement process by JSW has received overwhelming response with close to 175 applications from all three GPs-close to 40 applications were received from Dhinkia GP, 100 from Nuagaon

Further, process has been initiated for additional engagement of 1000 youth with both technical and non-technical background from the project affected villages.

For loss of betel vines, compensation of Rs. 17500 per decimal has been declared which is almost three times more than the government provision of Rs 6000 per decimal.

For the first time, a differential compensation of Rs. 6000 per decimal is offered to all the old betel vine owners, who earNuagaon, Gobindpur, Patana, Dhinkia and Mahala; who have not received betel vine compensation or have not received any labour compensation earlier from erstwhile projects, betel vine labour compensation of Rs 88,000 - Rs 44,000/- as onetime financial assistance after demolition of all betel vines and Rs 44,000/- balance as additional bonus after completion of boundary wall of the entire project area has been offered.

Each family under the Jangal Surakhya Committee will be paid Rs 50,000/- and the number of the families associated with the Jangal Surakhya Committee will be selected based on the records and proceedings of the committee for past three years.

For the Prawn Ponds with requisite permission from competent authority, a compensation is Rs.2.5 lakh per acre will be provided.

The company said a doorto-door survey in the land losing villages will be carried out to identify one eligible member between the age group of 20-3r yrs from the ration card holder families for engagement.

Company would try to provide direct or indirect engagement to one member from each ration card holding family in land losing villages would be given in any of JSW group companies, associated company or contractors of the plant or project agencies, in a phased manner.

It may be noted here that the integrated steel mill of JSW is to come up in the site which had earlier been selected for the POSCO plant which was shelved following stiff resistance by people.
